

## **LEGAL NOTICE**

### **I. IDENTIFICATION DATA**

In accordance with Article 10 of Law 34/2002, of July 11, 2002, on Information Society Services and Electronic Commerce, we inform you of the following information:

1. The present portal, <http://www.ucavila.es>, constitutes the Official Website of the UNIVERSIDAD CÁTOLICA SANTA TERESA DE JESÚS DE ÁVILA (UCAV).
2. The UCAV is a private university institution that was created on August 24, 1996, by the Bishop of Avila and is registered in the Registry of Religious Entities of the Ministry of Justice under number 017220.
3. The UCAV has CIF number: R-0500336-C.
4. The headquarters of the UCAV is located at Calle Canteros s/n, 05005 Ávila.
5. Users of this portal may contact the UCAV by means of written communication sent to its registered office, indicated in the previous point.

### **II. INTELLECTUAL AND INDUSTRIAL PROPERTY RIGHTS**

1. Both the design of the Portal and its source codes, as well as the logos, trademarks and other distinctive signs appearing therein, are owned by the UCAV or collaborating entities and are protected by the corresponding intellectual and industrial property rights.
2. The reproduction, transformation, distribution, public communication, making available to the public and, in general, any other form of exploitation, partial or total, of the elements referred to in the previous paragraph are prohibited. These acts of exploitation may only be carried out with the express written authorization of the UCAV and, in any case, must make explicit reference to the ownership of the aforementioned intellectual property rights of the UCAV. Under no circumstances may any protection devices or security systems that may be installed be removed, altered, evaded or manipulated. In particular, the materials made available by the teaching staff through the Website shall be for the exclusive use of students for educational purposes.
3. The UCAV declares its respect for the intellectual and industrial property rights of third parties; therefore, if you consider that this site may be violating your rights, please contact the UNIVERSIDAD CÁTOLICA SANTA TERESA DE JESÚS DE ÁVILA (UCAV).

### **III. PUBLICATION OF IMAGES OF PERSONS**

1. In relation to images of persons appearing on the website, the UCAV makes the publication respecting the Organic Law 1/1982 of May 5, 1982, on the protection of the right to honor, personal and family privacy and one's own image.

2. The User is not authorized to reproduce, distribute and communicate photographic and video graphic images. These images are used, solely and exclusively, in the composition of graphic or video graphic files of graphic or video graphic files, elaborated to inform and publicize various activities of the University.

3. The treatment of images of students, teaching staff or administration and services personnel is carried out respecting the person, eliminating any captures or filming that could violate fundamental rights. The images are not used for purposes other than those expressed, nor are they transferred to third parties, except those authorized to the treatment.

In any case, the person affected by a publication on the website of his/her image may revoke the consent given, oppose the processing of the image, or exercise the rights of access or cancellation, at any time, by submitting or sending a letter, accompanied by a photocopy of his/her ID card and an updated photograph, to the UCAV.

#### **IV. CONDITIONS AND TERMS OF USE OF THE WEB SITES**

The User agrees to comply with these terms and conditions of use:

1. Not to introduce, store or disseminate on the websites, information or material that is defamatory, libelous, insulting, obscene, threatening, xenophobic, incites violence, discrimination based on race, sex, ideology, religion or that in any way violates morality, public order, fundamental rights, public freedoms, honor, privacy or image of third parties and in general the current regulations.

2. To adequately safeguard the "User Name" (Login) and "Password" (Password) provided by the University to Users, as identifying and enabling elements for access to the different services offered on the UCAV websites, undertaking not to cede their use or allow access to them to third parties, assuming responsibility for any damages that may arise from improper use of the same.

By virtue of the above, it is the User's obligation to notify the UCAV's Data Protection Department of any fact that allows the improper use of identifiers and passwords, such as theft, loss, or unauthorized access to them, in order to proceed to their immediate cancellation. Until such events are reported, the University will be exempt from any liability that may arise from the misuse of identifiers or passwords by unauthorized third parties.

3. Not to carry out advertising, promotional or commercial exploitation activities through the Websites.

4. Not to use false identities, nor to impersonate the identity of others in the use of the Web site or in the use of any of its services, including the use of passwords or access codes of third parties or in any other way.

5. Not to destroy, alter, use for use, render useless or damage the data, information, programs or electronic documents of the UCAV or third parties.

## **V. PARTICULAR CONDITIONS AND TERMS OF USE OF CERTAIN SERVICES**

Some services belonging to the UCAV have, due to their peculiarities, particular conditions and terms of use. The applicable general conditions set forth in the previous section shall be applicable to them, as long as they do not oppose the particular conditions.

## **VI. UCAV'S EXONERATION OF RESPONSIBILITY**

- 1.** The UCAV is not responsible, in general, for the inappropriate use of the Website owned by the University. Users must make proper use of the Website, in accordance with the above terms and conditions, and UCAV shall not be held liable for any improper use.
- 2.** With respect to possible technical deficiencies, UCAV shall not be liable in any case for alterations in the service caused by failures in the electrical network, in the data connection network, in the server or in any other services.
- 3.** With regard to access by third parties to its system, UCAV shall adopt the necessary technical precautions in order to protect the data and information accessed, but shall not be liable for actions of third parties who, in violation of the established security measures, access the aforementioned data.
- 4.** Regarding the accuracy of the Information, the information contained in the Web site has been elaborated exclusively for informative purposes and has no official value, except when so indicated.
- 5.** The existing information and contents may be changed or withdrawn without prior notice. Likewise, improvements or changes may be made to the products, services, design or programs used for its operation at any time and without prior notice.

## **VII. APPLICABLE LAW AND JURISDICTION**

The present conditions and terms shall be governed by the statutory and regulatory rules and by the Spanish legislation, which shall be applicable in all matters not provided for in this legal notice regarding interpretation, validity and execution.

The parties expressly waive the jurisdiction that may correspond to them and expressly submit to the Courts and Tribunals of Ávila to resolve any dispute that may arise in the interpretation or execution of these conditions.
